### **Emergency Care**

.01 In the event Client's dog(s) require medical attention, Client authorizes Dog Leg to administer aid and retain veterinarian expenses. Dog Leg will take reasonable steps to contact Client prior to administering care or seeking medical services; however, Client understands and acknowledges that in the event of an emergency, or if Client cannot be contacted, Dogleg is authorized to act independently to safeguard the health and well being of Client's dog(s).

.02 Client agrees to Dog leg Productions using the most available licensed veterinarian necessary.

### **Medical, Dietary or Behavioral Issues**

.01 Upon delivery of dog(s) for boarding, Client shall inform Dog Leg of any medical, dietary, or behavioral issues pertaining to Client's dog(s) of which Client is aware. Dog Leg shall not be responsible for any harm caused to or by Client's dog(s) as a result of a medical, dietary, or behavioral issues of which Dog Leg was not informed.

.02 Dog Leg offers a nurturing environment for dogs of all ages and we are conscientious in maintaining the health, safety, and well-being of every dog boarded with us. However, old age, stroke, or other infirmities are, by their very nature, beyond anyone's control. Client understands and agrees that Dog Leg cannot guarantee against such naturally occurring acts.

### **Specific Lien**

.01 A specific lien is the right to retain specific property for payment of a debt. Client understands and agrees that Dog Leg holds a specific lien on dog(s) boarded for Client. The specific lien shall cover all charges reasonably incurred for boarding services including, but not limited to: housing, food, labor, and medical costs.

### **Entire Agreement**

.01 This agreement and the attached Owner Information Sheet and Dog Information Sheet represent the entire agreement between Dog Leg and Client and supersedes any and all other agreements, either oral or in writing, between the parties to this agreement with respect to its subject matter, and no other agreement, statement, or promise relating to the subject matter of this agreement that is not contained in it shall be valid or binding.

### **Attorney's Fees**

.01 If any action at law or in equity is brought to enforce or interpret the provisions of this agreement, the prevailing part shall be entitled to reasonable attorney's fees in addition to any other relief that may be available.

### **Governing Law**

.01 The validity of this agreement and of any of its terms or provisions, as well as the rights and duties of the parties to this agreement, shall be governed by the laws of the State of Florida.

**Amendment**

.01 This agreement may be amended by the mutual agreement of the contracting parties in writing attached to and incorporated into this agreement.

PROVIDER AND ALL OTHER CLIENTS OF PROVIDER SHALL NOT BE RESPONSIBLE FOR LOSS OR INJURY DUE TO THE UNPREDICTABILITY OF ANY DOGS, WHICH UNPREDICTABILITY MAY INCLUDE, BUT MAY NOT BE LIMITED TO, BITES, ATTACKS, OR SICKNESS CAUSED BY INFECTIOUS DISEASE OR OTHERWISE WITH RESPECT TO THE DOG OR ANY OTHER ANIMAL **DISCLAIMER OF WARRA&TIES:** CLIENT HEREBY AGREES THAT PROVIDER AND ALL OTHER WITHIN PROVIDER'S CARE. IN THE EVENT, THE DOG IS INJURED OR HARMED OR OTHERWISE PERISHES DURING THE TERM OF THIS AGREEMENT, FOR ANY REASON WHATSOEVER, CLIENT EXPRESSLY ACKNOWLEDGES AND AGREES THAT THE CLIENT IS RESPONSIBLE FOR THEIR OWN DOG'S MEDICAL CARE EXPENSES AND PROVIDER AND ALL OTHER CLIENTS OF PROVIDER WILL NOT BE RESPONSIBLE FOR ANY DAMAGES RELATED THERETO. PROVIDER'S MAXIMUM LIABILITY WITH RESPECT TO DAMAGES SHALL NOT EXCEED THE LESSER OF THE CURRENT CHATTEL VALUE OF A DOG OF THE SAME BREED OR SPECIES AS THAT OF THE DOG OR THE MAXIMUM SUM OF \$650.00. CLIENT HEREBY AGREES THAT PROVIDER SHALL BE RELEASED FROM ANY AND ALL LIABILITY WITH RESPECT TO THE CARE OF THE DOG. THE PROVISIONS SET FORTH HEREIN, SHALL SURVIVE THE TERMINATION OF THIS AGREEMENT. CLIENT ASSUMES ALL RISKS WITH RESPECT TO PROVIDER'S CUSTODY OF THE DOG, AND IN NO EVENT SHALL PROVIDER BE LIABLE IN ANY WAY FOR ANY DAMAGES INCURRED BY CLIENT RELATING TO SAME

.01 In case any one or more of the provisions contained in this agreement shall for any reason be held to be invalid, illegal, or unenforceable in any respect, this invalidity, illegality, or unenforceability shall not affect any other provision of this agreement and this agreement shall be construed as if the invalid, illegal, or unenforceable provision had never been contained in it.
